






## From the Chief of Police





The Annual Fire Safety report has eight (8) reporting requirements that consist of the following:

(1) Fire Statistics. The USF Department of Housing and Education (Housing) has developed the

to compile and track HEA/HEOA-required fre log statistics for the three most recent calendar years for which data are available. A fow chart outlining the process of handling fre alarm activations in Housing buildings is provided on the next page.

(2) Building Fire Safety Systems. Housing has developed the

document that lists the fre safety systems devices in each housing building.

(3) Fire Drills. The first reporting year is calendar year 2009 and will report from there on. The law requires reporting of a three year period, beginning with calendar year 2009. USF Fire and Emergency Drill Policy number 6-025 addresses procedures and responsibilities.

1. Emergency notif cation procedures are contained within the USF Emergency Operations planned (July 2010) and lists USF officials authorized to activate the emergency notif cation systems during emergency or dangerous situations.

2. The USF Emergency Operations Plan lists standing priorities for all Incident Commanders. Life Safety is the primary responsibility, followed by incident stabilization and property preservation. The EOP clearly indicates that nothing shall inhibit or create a delay in saving lives, and that immediate warnings shall be issued for all incidents that pose an immediate threat to public safety.

3. The USF Emergency Operations Plan delineates internal communication notif cation procedures and the individuals responsible for initiating the notif cation.

4. The USF Emergency Operations Plan lists the titles of persons/organizations responsible for initiating internal communication notif cation and emergency notif cation systems.

5. The USF Emergency Operations Plan lists the responsible parties charges charged with disseminating emergency information to the larger community.

6. USF Policy 6-025 covers Fire and Emergency Evacuation Drills (generalcounsel.usf.edu/policiesand-procedures/pdfs/policy-6-025.pdf).The University of South Florida conducted two exercises to test emergency response and evacuation procedures. Both exercises were announced.

a. The frst exercise was conducted on June 7, 2010 and involved the activation of the Emergency Operations Center, members of the Critical Incident Planning/Management Group and Executive Policy Group. The exercise incident incorporated a hypothetical localized explosion at a dining facility due to a natural gas leak. The incident resulted in the activation of the emergency notif cation system, the evacuation of a resident hall and off ces in the immediate area, and relocation of students to temporary housing. The scenario also contained elements that involved student tracking (as some students were hypothetically transported to nearby hospitals) and parent/next of kin notif cation. b. On June 23, 2010, the University of South Florida conducted an exercise that focused on post-incident activities and affects from a Category-4 hurricane incident. The exercise involved the activation of the Emergency Operations Center, Critical Incident Planning/Management Group, Executive Policy Group, and select members of the Campus Emergency Preparedness Committee. Exercise activities included, but were not limited to business continuity, sheltering, debris management, campus security and law enforcement, search and rescue, resource management, and mass notif cation processes.

7. The USF Division of Public Safety, Emergency Management, and University Police have been engaged in presenting campus shooter scenario protective actions awareness training since April 2010. The training involves a presentation of the "Shots Fired on Campus" video with an open discussion of protective actions, an overview of emergency management program initiatives, and a description of the USF Emergency Notif cation System. The video is available for online viewing to all students, faculty, and staff with valid USF credentials. A total of 31 presentations and open forums have been conducted across the USF Tampa, Sarasota/Manatee, St. Petersburg, and Lakeland campuses.

8. The USF Division of Public Safety and Emergency Management in cooperation with the USF Provost Off ce and Faculty focus group developed a Protective Actions ready reference card. The double-sided laminated card provides professors ready reference within their classrooms of recommended protective actions that should be considered for the myriad of hazards that could affect the campus population.

9. The USF Division of Public Safety and USF Emergency Management launched a public education campaign in April 2010 to increase subscribership to the USF's cellular phone notif cation system "MoBull" and pilot test software components Guardian911 and Smart911 2010to notMMtm the to a"f a a 2010a the the( ampaignto
